



#### **COURTESY VISIT TO FLOUR MILLS PLC**

On 11th May 2023, the National President led a team on a courtesy visit to Flour Mills Nigeria Plc, Apapa, Lagos, to meet with Mr. Wale Adediran, the Human Resources Director of the Company. The visit coincided with the birthday celebration of Adediran. The General Secretary, in his opening remarks, appreciated and celebrated Mr. Adediran on the occasion, making reference to his level of understanding, maturity, and cooperation love, displayed during all industrial engagements. The National President speech in his expressed appreciation for the assistance rendered to the Branch when required. The President, however, emphasised the issue of salary overlap, and salary disparity within the Flour Mills Group in Nigeria; the outstanding meeting to discuss appendix B and monthly samples which were not granted to Premium Edible Oil Limited and Premium Cassava Limited Staff. He called on the Human Resources Director to address these issues with the urgency they deserve. The President further urged Mr. Adediran to remain in the Company until the Union's NJIC proposal is submitted, discussed, and signed, because of his importance and influence as President NJIC Chairman. In conclusion, the expressed the hope that the membership strength will increase coupled with the fact that Flour Mills is one of the founding Branch of the Association and should lead in terms of the membership drive.





The Human Resources Director in his response appreciated the National President and his team for the visit to the Company. While addressing the issues raised by the National President, he noted that he will not make any promise on the NJIC agreement because he will soon retire from the service of Flour Mills of

Nigeria, but he advised the Association to present its proposal early enough to AFBTE for pre-meeting, which he believed would have a positive impact on the NJIC negotiations. He also responded to the issue of salary disparity and salary overlap within the company, and explained that because the employees work in different locations, it was not practicable to pay them the same salaries and allowances, due to the difference in the cost of living. He promised to intervene and ensure discussions on Appendix B and monthly products for staff in the Company were concluded before his exit.



The quality of life is proportional to the quality of decisions one can make in life. Decision-making is a source of trouble and anxiety for many people. Some people are afraid to decide their next move or undecided on how to cope with a situation, while others move forward to action and gain the results of their actions. Indecision always comes with a heavy cost at times. Decisions and actions are the ingredients that propel you forward and drive you toward the implementation of your goals. Without decisions and action, one would be in a state of prolonged procrastination without doing and/or chasing anything that means cost. Cost at unimaginable levels including your relationships, health, financial status, personal development, work, etc.

When this happens, how do you remedy it? There are various approaches but the first is to understand the causes of the problem.

#### **The Causes of Indecision**

Many times, it may take you a long period of time to reach a decision or implement one. This is normal but it becomes a deeper problem when you refuse to take a decision or postponed decision-making indefinitely.

Indecision is fraught with many reasons that include fear, analysis paralysis, anxiety, etc. all of which can delay a decision process and invariably delay decision-making to an extent. Any of these factors can overwhelm, pause, or stall decision-making actions.

### The Cost of Inefficient Decision-Making

There is no iota of doubt, that indecision cost money, time, opportunities, resources, and a lot of effort in trying to catch up with the things that should be done in a prior time and the cost can be great depending on the situation or the status of the people involved.

Imagine you found yourself in a position where you need to take split-second decisions or you need to act on impulse. Life can create such challenges and you need to be ready to rise above the circumstances. Failure to do so can create conditions for the growing of indecision and thus create isolation, imbalance, and thought paralysis that negates specific decisions.

The exordium of no-action situations can create long-run effects and the growing of indecision, building tendency you may have adopted which unavoidable would lead you to procrastination, energy, money, opportunities, and focus drainage. In turn, long procrastination periods would lead to ineffectiveness, and weakness to decide and reaching your goals. The only cure is to assume ownership of your actions and the outcome of the results produced.

### **Take Ownership of your Actions**

There is need to change one's mindset, to be able to own your action(s), the results you produce and to shift from your current situation to a high-studious situation in which:

- You completely own your initiatives, actions and their results
- Adopt proven and scientific-based methods in order become more effective and productive,
- Embed the no-complain rule, start using your resources effectively and creatively without blaming others,
- Set clear and SMART goals and priorities,
- Keep-on moving forwards.
