The General Secretary, Comrade Solomon Adebosin, in addressing the members at the meeting, reminded the Branch Chairpersons to open an official email for their various branches which will serve as an archive for the present and future Executives. He added that Branches that fail to comply with the directive would receive official communication no longer information from the National Secretariat. appealed to all the Branches to forward their official emails to the National Secretariat for records and update. He reminded the members that the Association's Logo which was changed last year would be launched at the 45th Anniversary Celebrations in August and the onus is on the Branches to ensure their letterhead reflect the latest logo. Comrade Adebosin mentioned that whenever a member gets promoted or resigned from the union, there is a constitutional and mandatory three months notice that should be served out before union deductions get stopped. He added that before

any Branch can carry out a trade union action, the National Secretariat must be aware or pre-informed. He noted that part of the proposed amendment to the Association's Constitution was the requirement for every branch to hold meetings quarterly and send the report of such meetings to the National Secretariat. He noted that the constitutional tenure of Branch Executives was three years and the Secretariat would be sending reminders to Branches to conduct elections once the tenure is about to be completed. He added that Branch Executives should educate the members on how to respond to queries, so that it does not result in unwanted outcomes. He concluded his remarks by reminding the branches about the
