FOBTOB TRAINING (MORTGAGE ACQUISITION)

A virtual training organized by the National Employee's Consultative Association (NECA) was held on the 19th October 2022, with two (2) facilitators from the Federal Mortgage Bank of Nigeria and Trust Fund.

The training focused on how employees who are in regular employment can access a loan to acquire a mortgage to be funded from employees' NHS/RSA contribution.

The facilitators based their presentations on the methods/conditions and the accessibility of RSA/NHS funds. Following conditions must be followed to acquire a mortgage from the mortgage lenders:

- **APPLY IN PERSON:** All applications for contribution for residential eauity mortgage shall be done in person
- RSA DATA CAPTURING: all records must be updated records through RSA data recapture with Trust fund
- **ACTIVE EMPLOYMENT:** applicant must be in active employment, as a salaried employee or self-employed person.
- PURPOSE OF MORTGAGE: the equity contribution portion is solely for the purpose of a residential mortgage
- 25% LIMIT ACCESS: A limited 25% shall be given to an employee either from his/her RSA contribution NHS or voluntary contribution.
 - **JOINT APPLICATION:** Married couples, who are RSA holders are eligible to make a joint application subject to individual adherence required quidelines.

CUMULATIVE CONTRIBUTION: Both employer and employee contributions for a cumulative period of 60 months (5 years) before you can apply for a residential mortgage.

STEP-BY-STEP APPLICATION AND DOCUMENTATION PROCESS

- RSA holder shall identify a property and obtain a property offer letter from the property mortgage lender.
- RSA holder shall approach and obtain a mortgage application form from a mortgage lender and attach a property offer letter.
- The Mortgage Lender shall verify the genuineness of the property offer and ensure the property has a valuation report.
- Upon confirmation of the property offer letter by the Mortgage Lender, the applicant shall
- approach his/her PFA and request his/her RSA statement to access 25% of his/her RSA balance for payment of equity contribution.
- In a joint application, each party shall apply to their respective PFAs with copies of the verified property offer letter.
- The PFA shall issue a duly endorsed RSA statement to the Applicant and update its record. The Applicant shall forward the statement to his/her Mortgage Lender.
- Upon receipt of the duly endorsed RSA statement, the Mortgage Lender shall verify if the 25% of the applicant's RSA balance will be sufficient as an equity contribution.

The facilitators did justice to the topic, afterward, various questions were asked, and answers were provided adequately by the facilitators. Some of the questions and answers proffered were as follows:

1.Question: can employee that has a contribution with PFA and NHS be able to access 25% each from his/her contribution?

Answer: The answer given by the facilitators is yes.

2.Questions: Can someone who already have a landed property be able to access 25% from His/her RSA account

Answer: No, you cannot access or benefit from Mortgage lender to build your house by yourself. The loan is only available to employee who want an already built house from Mortgage Lender.

Note: Interested and qualified employee must adhere to aforementioned guidelines/conditions for a successful mortgage acquirement.
